You will need an **Athens** username and password to access many of the library's full text journals and databases. You can look up your Athens details on the **StudentWeb** at <http://studentweb.ulster.ac.uk> (you will need your student ID and PIN to access the StudentWeb).

Primary legislation (Acts, Statutes)

Primary legislation affecting Northern Ireland may come from many sources:

UK Statutes (Acts of Parliament at Westminster)

eg Electoral Fraud (Northern Ireland) Act 2002 c. 13

NI Statutes

Acts of the Northern Ireland Parliament

eg Electoral Law Act (Northern Ireland) 1962 c. 14

Acts of the Northern Ireland Assembly

eg Budget Act (Northern Ireland) 2002 c.3

NI Orders in Council (made under direct rule arrangements)

eg Dogs (Northern Ireland) Order 1983 S.I. No. 764 (N.I. 8)

EC legislation

eg Treaties, Directives, Regulations

Search tip

Sometimes a useful way of telling whether an Act was passed at Westminster or Northern Ireland is by the position of the words "Northern Ireland" in the title. Generally if "Northern Ireland" comes before "Act" then the Act was passed in Westminster; if "Northern Ireland" comes after "Act" it was passed by the NI Parliament or the NI Assembly.

Secondary legislation

Secondary legislation (also called delegated or subordinate legislation) provides detail not included in the primary legislation. Both the UK and NI have their own sources of secondary legislation. They are:

UK Statutory Instruments (SIs)

Statutory Rules of Northern Ireland (SRs)

Use to access UK Statutes and UK SIs currently in force, EU legislation and US legislation.   

[Legislation Direct](#)

Full amended text of current UK Statutes and UK SIs.   




[UK Statutes and UK Statutory Instruments \(Justis\)](#)

Use to access the full text of UK statutes as originally enacted with amendments; UK SIs from 1949 onwards are also available.   

[CELEX](#)

The official EU legal database which includes treaties, directives etc   

[Halsbury's Laws Direct](#)

Major legal encyclopaedia; use to find legislation in force in a particular subject area.
